Contemporaneous is the dispatch of this document to the most member States of the excellent  
ONU World Organization : WIPO\_TRIPS\_WTO .

REQUEST:- CONFERENCE of MINISTER, with advice of T.R.I.P.S. COUNCIL 1994 AGREEMENT, to  
provide a valid World International Protection for my intellectual royalties.

#### PRELIMINARY REMARK

a) WIPO has been founded with purpose of "to promote through international cooperation the  
creation, dissemination, use and protection of human mind for economical, cultural, social,  
and to-day preliminarily environment, progress of all humanity".

At 1974 this Organization got a specialized Bureau with ONU and in 1996 it has agreed in WTO  
with one's own functions that have emphasized the growing importance of intellectual property  
(copyright) in the international business;

b) TRIPS has been adopted at 1994.04.15 by means of "AGREEMENT CONCERNING TO RELEVANT  
ROYALTIES TO TRADE".

All this to help a sufficient and effective protection of an intellectual property (copyright, project,  
patent with know-how and secret industrial/commercial informations) and working so that steps  
and procedures to put into practice don't must be obstacle to lawful trade;

c) WIPO and TRIPS with all these factors help to make it a success!;

d) It so happens that the fundamentals "III° Section TRIPS Imposition Established Requirements":

- to have laws on intellectual property it's not sufficient. These laws must be applied !;
- the international agreement fixes that GOVERNMENTS must guarantee that royalties may  
be applied under its laws, and that the sanctions for violations may be rather severes so  
that to spring a deterrent for further transgressions;
- it's point connection out between the intellectual property protection and technological  
development at article 7 TRIPS Regulation. This is very important to-day for total recovery  
and recycling Urban Assimilable Refuse (just like developed X-ray) in the best environment  
for interest of consumer and producer citizens;



e) My demand to WTO is liable to the principle egalitarian treatment of several different Peoples;

f) It's defined in UNIVERSAL CONVENTION the legal times and various form of protection royalties.

My possible resolution does not depend on me but by definitive behaviour of Italian Government within 2010.04.30;

g) I should like to specify to Excellent WTO ORGANIZATION, personally Mr. Pascal Lamy in function of Director General, that the divulged provision of CALABRIA Dialect Pronunciation n. 1288/1996 to carry out the industry for recovery and recycling 1320 tons/annual of urban assimilable refuse has been laied down in force of (ex article 3bis Law n. 441/1987) actually Legislative Decree nr. 22/1997 article 27.5 : "the assent substitutes to every effects the endorsements, the opinions, the authorizations and concessions of regional, provincial and municipal orders. The same assent is variant to town-planning, it's declared of public utility, urgency and work that can't be deferred". This article has been confirmed on provision 91/156/CEE - G.U. n. 38 of 1997.02.15;

h) The legal analysis of what I have expressed, that may be verified in archives of the site demetrio chiodi on GOOGLE, it marks that I can't to be defined PRIVATE INDIVIDUAL or ENTERPRISE or ENTITY because it's ILLEGAL the EXISTENCE of PUBLIC UTILITY OUTSIDE of ME.

The PATENT n. 00228701 that has been adjudicated TO ME by Italian Ministry Industry-Trade-Craftsmanship quotes DEMETRIO CHIODI "INVENTOR" of:

"INDUSTRIAL CHEMICAL-PHYSICAL PLANT OF ASSIMILABLE URBAN SPECIAL REFUSE AND THEM TOTAL TREATMENT-GETTING RID WITH INTEGRAL RECOVERY OF RAW SECOND MATERIALS AND RECYCLING IN CLOSED CIRCUIT OF PRIMARY PROCESSING WATER".
